Guide for completion of Declaration of Estimated Tax form (ES1)

- Line 1 Enter the amount of your estimated Earned Income Tax liability based on 1% of the anticipated income to be received from self-employment and from W2's and 1099 MISC forms. Income from W2's and 1099 MISC forms should not be added if included as part of your self-employment estimated income calculation.
- Line 2 Estimated Earned Income tax to be deducted and which will appear on a W2.
- Line 3 Total of Line 1 less Line 2
- Line 4 Enter credit from the previous years Earned Income Tax Final Return you elect to apply.
- Line 5 Use only if amending a previously filed estimated tax form for this year.
- Line 6 Line 3 less sum of Lines 4 and 5.
- Line 7 Amount due when returning the Declaration of Estimates Tax form. Checks should be made payable to Parkland School District.
