REVISED GRADING PLAN FOR HIGH SCHOOL (4th Marking Period During eLearning)

There are no final exams, all students are considered exempt from the Final and will have their grade calculated based on the quarterly percentages with mid-term exams reported during the year.

Additional Grading Information:

If students achieve a passing grade for the fourth marking period, their final grade for the course will not be negatively impacted by eLearning. The intention of the final grade calculations outlined below is to be as beneficial to students as possible.

Student final averages will be calculated as follows:

- 1. Students enrolled in a **full year course** will have their final averages calculated using marking period grades from the first, second, third and mid-term exam grades. Fourth marking period grades will be included or excluded as defined below. The final course grade will be included in the calculation of GPA at the end of the year. (note: The formula follows the student handbook for a student exempt from a final where the quarterly average is 90% of the final grade and mid-term is 10% of the final grade.)
 - If a student's fourth marking period **grade is a passing grade and increases their average** for the year, it will count toward the final grade calculation.
 - [(4 rating period rounded average) * 9 + Mid-Term Exam grade] / 10 = Final Grade.
 - If a student's fourth marking period **grade is a passing grade but decreases their average** for the year, it will not count toward the final grade calculation.
 - [(3 rating period rounded average) * 9 + Mid Term Exam grade]/10 = Final Grade
 - If a student's fourth marking **grade is a failing grade**, it will be counted toward the final grade calculation.

 [(4 rating period rounded average) * 9 + Mid-Term Exam grade] / 10 =
 - [(4 rating period rounded average) * 9 + Mid-Term Exam grade] / 10 = Final Grade
- 2. Students enrolled in a **semester course** during marking periods one and two will have their final grade earned in this course count in calculations of GPA.
- 3. Students enrolled in a **semester course** during the third and fourth marking periods will have their final grade calculated as defined below. The final course grade will be included in the calculation of GPA at the end of the year.
 - If a student's fourth marking period **grade is a passing grade and increases their average** for the year, it will count toward the final grade calculation.
 - (third marking period grade + fourth marking period grade) / 2 = final grade

REVISED GRADING PLAN FOR HIGH SCHOOL (4th Marking Period During eLearning)

- If a student's fourth marking period grade is a passing grade but decreases their average for the year, it will not count toward the final grade calculation.
 - (third marking period grade) = final grade
- If a student's fourth marking grade is a failing grade, it will be counted toward the final grade calculation. (third marking period grade + fourth marking period grade) / 2 = FinalGrade
